

Jetty Masters Cottage

Coastal Hamlets Pty Ltd has submitted to LMCC a Development Application for "Reconstruction of existing dwelling damaged by fire", i.e. the Jetty Master's cottage. The "Reconstruction" proposed has a gross floor area of 504m², approx. 4 times the size of the original cottage!

If approved, this development will

severely detract from the heritage values of the Bay. So significant are the heritage values considered that the town has been placed on the NSW Heritage Register; only the second town in NSW to be given this recognition.

The development is located in a highly sensitive position and the proposed building is of such a large scale that it is totally out of keeping with the modest cottages that characterise the Bay.

Report - Coal & Allied's Middle Camp Development

C&A have been busy finalizing their DAs for Gwandalan and Nords Wharf and on completion, C&A will then turn their attention to Catherine Hill Bay.

Report - Rose Group's Development

Meeting held at the Surf Club, 7th July 2014 - Committee Attendees were Sue Whyte, Damien Hawcroft, Nick Jackman (Senior Development Manager – Rose Group), Ian McNicol (AWDJohnson – Chairperson and facilitator), Ben Read (Daracon construction contractors), as well as Kay Fraser (Councillor) from LMCC.

This Committee was set up as part of the Approval given to Rose Group to build 550 houses at the southern end of the Bay. A Committee meeting is to take place every 1 to 2 months.

Nick Jackman advised that clearing of Project stages 1, 2, 4 and 5 was underway. Bulk earthworks would not commence until sign off from the site auditor was received and this was anticipated to be sometime in July 2014. Design of lead in works (e.g. Montefiore St) is underway.

Daracon stated that emergency vehicle access would be provided, should the need arise, during the works requiring the closure of Montefiore St, planned 4th Quarter 2014.

Daracon confirmed that during the closure of Montefiori St their employee and subcontractor vehicles would be required to arrive and leave the development project via Montefiori St and that no project traffic would be using Clarke St.

PLEASE NOTE: Rose Group confirmed that the South Catherine Hill Bay DCP identified plantings, a pathway, a detention basin, a playground and a picnic area for the village green, i.e. eastern side of Clarke St. Community representatives expressed their concern regarding these "identified works" being not in keeping with the Heritage footprint of the village. Rose Group advised community representatives that if there were any concerns regarding these "identified works" then they needed to be addressed by the Community at Council level.

Traffic Management Plan (TMP)

Peter McMurray (Transportation & Asset Planning Co-Coordinator Lake Macquarie City Council) attended the meeting and told us that the funding set aside to implement the TMP for this financial year had had to be re-allocated to the Children's Games at Speers Point Park in December 2014.

Detailed design plans for the Bay's speed reduction measures would be made after January 2015 and money allocated in the next budget would be put towards the implementation of the traffic plan for Catherine Hill Bay.

Fire Control and Documentary

Residents of the Bay, please note: From August 2014 NSW residents in fireprone regions are allowed to cut trees within 10 metres of their homes and clear lower level vegetation out to 50 metres without a permit, to help mitigate fire threats.
